

Cheese Color DS - Liquid 423506

DESCRIPTION

Dark reddish-black liquid used to color food and beverage products. This color is permitted for use in foodstuffs pursuant to the USA Food and Drug Administration.

STORAGE

Store color additive in closed container at ambient temperature (<22C/72F) and < 60% relative humidity. Avoid exposure to direct light, freezing, heat and moisture.

SHELF LIFE

Typical shelf life is at least 6 months from date of manufacture under recommended storage conditions.

NUTRITIONAL CONTRIBUTION

The nutritional content of color additives does not contribute to the nutritional value of foods, due to the extremely low use level. For the USA, 21CFR 101.9 (j) (4) lists the color additive exemption from nutritional labeling. Nutritional data is available upon request.
